Volvo Padel Open 2025

AGREED TERMS

The definitions and rules of interpretation for the following Terms & Conditions ("Terms and Conditions") are as follows:

- "Tournament" or "the Tournament" refers to the Volvo Padel Open 2025 to be held between the 3rd of June to the 27th of July 2025.
- "Organiser" or "the Organiser" refers to Volvo Car Malaysia Sdn Bhd with Registration No. 199901007530 [482430-K] with its business address at Lot 01-13A, 13A Floor, Menara Symphony, 5, Jalan Professor Khoo Kay Kim, Seksyen 13, 46200 Petaling Jaya, Selangor, Malaysia.
- "Event Partner(s)" refers to JOY DIVISION PADEL SDN BHD with Registration No. 202401022348 [1568197-W] located at Lot 20D, Jalan Penchala, Petaling Jaya, 46050 Selangor, Malaysia ("Joy Division Padel"); PADELGROUND MALAYSIA SDN BHD with Registration No. 202201032444 [1478141-H] located at 3, Jalan Bukit Kiara 1, Bukit Kiara, 60000 Kuala Lumpur, Wilayah Persekutuan Kuala Lumpur, Malaysia ("Padelground"); and/or PADELKU MEGAH SDN BHD with Registration No. 202401032102 [1577591-X] located at Lot 3470, Jalan SS23/15, Taman Sea, 47300 Petaling Jaya, Selangor, Malaysia ("PadelKu Megah"), who are the participating padel court operators for the Tournament.
- "Food and Beverage Partner(s)" refers to Padelground, WAKU WAKU or any food and beverage partner(s) appointed by Joy Division Padel, or PadelKu.
- "Agent" refers to persons, contractors, service providers, match referees, linesmen, volunteers and agencies appointed by the Organiser and/or the Event Partner(s) to facilitate the organisation of the Tournament.
- "Participant" refers to individuals taking part in the Tournament that have completed the registration process.
- "The Volvo Experience" shall mean the loan of a current-model Volvo car between 28
 July 2025 to 31 December 2025, subject to availability of cars and dates at the full
 discretion and schedule of the Organiser.

GENERAL

- 1. The Organiser reserves the right to unilaterally add on, modify or substitute any of the terms and conditions below at any time as it deems fit without prior notice. If there is ambiguity in any of the provisions of the Terms and Conditions, the Organiser shall have sole discretion to interpret the ambiguous provision(s) as it deems fit.
- 2. If you cannot accept these Terms and Conditions or the risks associated with the Tournament, please do not proceed further with registration for this Tournament. By participating in the Tournament, you have read and understood the rules and regulations of the Tournament as released from time to time and agree to participate on the understanding that you must adhere to all the rules and regulations stipulated.
- 3. By participating in the Tournament, you acknowledge you have read and agreed to all the provisions in the Terms and Conditions for the Tournament. The Organiser reserves the right to refuse, disqualify or restrict you from participating in the Tournament and/or accessing the entitlements of the Tournament and claims thereto.

TOURNAMENT REGISTRATION

- 1. Registration for the Tournament can only be done via the official website at https://padel.volvocarmalaysia.com. No registration is allowed via email, mobile communications, or direct communications with the Organiser, Event Partner(s), and/or Agent(s).
- 2. The following persons are not allowed to participate in the Event:
 - a. Executive directors and employees of the Organiser and Event Partners;
 - b. Contractors, affiliates, appointed agents or agencies, business partners, suppliers, and representatives of the Organiser and/or the Event Partners;
 - c. Certified, full -time padel coaches;
 - d. Non-citizens or non-residents of Malaysia without a valid student visa, work permit or Long-Term Social Visit Pass ("Spouse Visa");
 - e. Registrants below the age of eighteen (18) years; and/or,
 - f. Persons with a health or medical condition that can pose a risk to their health or wellbeing of others by participating in the Tournament.
- 3. Registration for the Tournament can be done between Tuesday, 3rd of June 2025 and Tuesday, 3rd of July 2025, or until available Tournament slots are fully filled.
- 4. The Organiser reserves the right to close registration early and/or move new registrations into a waitlist if Tournament slots are filled.
- 5. Registrants shall have twenty-four (24) hours from the time of account creation to complete the process and make full payment for the Tournament Registration, otherwise the Tournament slot will be released to other registrants in the queue.
- 6. Registrants on the waitlist are not considered Participants until they have been directly contacted by the Organiser and/or its Agents with confirmation of the registration process.
- 7. The following details will be collected as part of the registration process: Full name, email address, mobile phone number, national identification number and digital copy

- thereof, gender, t-shirt size of the registrant (and their teammate/partner if participating in the Intermediate or Advanced category).
- 8. For the Intermediate and Advanced categories, it is the registrant's sole responsibility to obtain their teammate/partner's consent to submit the teammate/partner's information before submitting the teammate/partner's information on behalf of the teammate/partner during the registration process.
- 9. Volvo car owners are additionally required to submit their Vehicle Identification Number ("VIN") and car model to enjoy additional participation benefits.
- 10. The Tournament categories and available slots are as follows:
 - a. Beginner up to one hundred and twenty-eight (128) players registering as individuals, regardless of gender.
 - b. Intermediate up to forty-eight (48) teams of two (2) players per team in the Men's category, and up to thirty-two (32) teams of two (2) players per team in the Mixed category. All-women's teams are allowed to participate in the Mixed category.
 - c. Advanced up to sixteen (16) teams of two (2) players per team in the Men's category, and up to sixteen (16) teams of two (2) players per team in the Mixed category. All-women's teams are allowed to participate in the Mixed category.
- 11. It is Participants' sole responsibility to register in the correct category based on a truthful self-assessment of their playing ability, or risk forfeiture with no refund.
- 12. Certified padel coaches who are not coaching full-time and are eligible for entry subject to the Organiser's approval are considered to be in the Advanced category by default.
- 13. Participants can register for up to two (2) categories, but risk forfeiture / walkover if their match timings clash. The Organiser is in no way responsible for conflicting match schedules nor is obligated to reschedule matches in the event of a conflict.
- 14. The Participant warrants and agrees that all information provided by the registrant during the registration process for this Tournament shall be true, accurate, current, and complete information. If at any point of time, the Organiser has grounds to believe that such information provided by the Participant is untrue, inaccurate, obsolete, or incomplete, the Organiser may disqualify, suspend, or cancel the Participant's registration without any disputes nor refunds of the registration fee.
- 15. The Organiser shall not entertain nor be in any way responsible for any disputes, discrepancies or complaints arising from incomplete or inaccurate entry details by the Participant during the registration process.
- 16. Registration for the Tournament shall only be deemed confirmed upon receipt of full payment and upon issuance of a confirmation email by the Organiser and/or its Agents.
- 17. Payments are processed by an authorised Agent of the Organiser through a secure, third-party payment gateway. All transactions are in Ringgit Malaysia and may be subject to currency exchange differences to be borne by the Participant if making payment via a foreign bank or credit card. The Organiser and/or its Agent(s) shall not be liable for any financial loss by Participants resulting from the misuse of said payment gateway.

PARTICIPATION FEES, NO-REFUND POLICY, AND PLAYER SUBSTITUTIONS

- 1. The Tournament registration fee is MYR 160 per individual, or MYR 320 per team in the Intermediate and Advanced categories.
- 2. Owners of Volvo cars with a valid Vehicle Identification Number ("VIN") will enjoy 50% off registration fees. For example:
 - a. A Volvo car owner registering in the Beginner category (individual) will only need to pay MYR 80.

- b. A team registration consisting of one Volvo car owner and one non-Volvo car owner will only need to pay MYR 240, or MYR 160 if both players are Volvo car owners.
- c. Only one (1) VIN per discount redemption.
- 3. The Organiser reserves the right to deny the discount for Volvo car owners if the VIN is found to be duplicated, erroneous, or not registered in Malaysia.
- 4. No refunds will be given for whatsoever reason once registrations have been successfully processed by the Organiser. This includes but is not limited to Participant withdrawals, walkovers, disqualifications, and forfeitures before or during the Tournament, or personal circumstances or reasons that prevents the Participant from participating in the Tournament and/or claiming Tournament entitlements.
- 5. Participants are strictly not allowed to transfer, sell, or swap their entries to another party. The Organiser reserves the right to revoke participation otherwise or to place the registered team under the waitlist.
- 6. Any requests for a change in category will forfeit the previous registration including any fees paid, and slots in the new category are subject to availability and upon the discretion of the Organiser.
- 7. Any Participation substitution requests for team categories (Intermediate and Advanced) can only be done upon written approval from the Organiser. No requests will be entertained after the 6th of July 2025.
- 8. While there are strictly no refunds, Participants who cannot play in the Tournament for whatever reason shall still be entitled to collect their official sports kit at their chosen Event Partner, subject to availability, and are still entitled to access to the event and hospitality during the Tournament finals at Joy Division Padel 2 (JOY2) on the 27th of July 2025.

PLAYER SKILL LEVEL ASSESSMENT

- 1. All Participants in the Beginner and Intermediate categories are required to undergo a skill level assessment to be eligible for participation in the Tournament.
- 2. Assessments will be 21st, 22nd, 28th and 29th of June 2025; and the 5th and 6th of July 2025 at Joy Division Padel, Padelground and PadelKu Megah.
- 3. Participants must choose an available slot upon registration. Slots and locations are available on a first-come, first-served basis.
- 4. Participants must be present at least 15 minutes prior to the start of their assessment slot. Entry to assessment slots closes 15 minutes after the stipulated starting time.
- 5. Any replacement slots are solely at the discretion of the Organiser and failure to undergo the assessment will result in forfeiture of participation in the Tournament.
- 6. The assessment will take around 10 minutes per player and will be performed by appointed coaches from each Event Partner.
- 7. Each player will be given a score derived from an international numerical system. The rating of "beginner" or "intermediate" will consider the player's overall ability to construct shots and maintain rallies at the current standard of Malaysian recreational padel gameplay.
- 8. Participants who are assessed higher than the category they registered for must participate in the higher category. For example, a Participant who registered for the Beginner category (individual) and is subsequently assessed as an intermediate player will no longer be allowed to play in the Beginner category and forfeit his or her place and registration fee. The Participant can re-register in the Intermediate category (team), subject to availability of registration slots and at the sole discretion of the Organiser.

- 9. Participants who are assessed lower than the category they registered for cannot substitute their registration for a lower category. For example, a Participant who registered for the Intermediate category (team) and is subsequently assessed as a beginner player will still have to play in the Intermediate category with his or her partner.
- 10. For team registrations (Intermediate and Advanced) with mixed skill levels for each player, Participants will have to register at the highest individual level within the team. For example, if a team who registered for the Intermediate category is found to consist of a beginner player and an intermediate player, they will still be considered an intermediate team. If a team who registered for the Intermediate category is found to consist of an intermediate player and an advanced player, the team will no longer be allowed to play in the Intermediate category and forfeit their place and registration fee. The team can re-register in the Advanced category subject to availability of registration slots and at the sole discretion of the Organiser.
- 11. Certified padel coaches who are not coaching full-time and are eligible for entry subject to the Organiser's approval are considered to be in the Advanced category by default.
- 12. Assessments are final and decided at the sole discretion of the appointed coaches and the Organiser. No Participant appeals will be entertained.
- 13. Assessments may be recorded on video for comparisons with actual participant performance during the tournament.
- 14. Misrepresentation of actual skill level during assessments can lead to immediate disqualification during the tournament.

TOURNAMENT CATEGORIES & GAMEPLAY

1. All matches in the Tournament are played in doubles format only according to the prevailing rules and regulations of padel as determined by the Organiser, with the following categories:

2. Participant groupings will be drawn randomly after all participants have been assessed. Participants will be able to view their groupings at the official Tournament leaderboard at https://padel.volvocarmalaysia.com by the 15th of July 2025 for the Beginner category.

- 3. Participants are required to be at the venue (refer to Key Dates and timing in your confirmation email) and present themselves to the Organiser, Event Partner(s) and/or the Agents at least 1 hour before the estimated start of their matches.
- 4. Participants can register for up to two (2) categories, but risk forfeiture / walkover if their match timings clash. The Organiser is in no way responsible for conflicting match schedules nor is obligated to reschedule matches in the event of a conflict.
- 5. Matches may be played with a custom scoring system within a set time predetermined by the Organiser and depending on the progression of the Tournament, to facilitate timeliness and a chance for all Participants to play. Participants will be briefed on the scoring and timeframe for matches prior to gameplay.
- 6. The official tournament t-shirt must be worn at every match.
- 7. Match formats are as follows:

a. Beginner Category

- i. Qualifiers will be played with 128 individual Participants on Saturday, the 19th of July 2025 at the three (3) Event Partner venues.
- ii. Participants will be randomly grouped into eight (8) groups of sixteen (16) players each, who are further split into sub-groups of eight (8) players each.
- iii. Qualifying matches are played in an americano format, where Participants compete individually while playing in pairs. Each Participant will play up to seven (7) matches teamed with and against every other Participant in his or her sub-group.
- iv. Before each match, teams choose to start the serve or their side of the court by winning a coin toss.
- v. The server serves four (4) times, alternating between the right and left sides of the court, after which it is the opposing team's turn to serve the same way.
- vi. Each match will be played to a total of twenty-one (21) points. For example, the match is over when the match score is 16-5, 21-0, 4-17, or combinations thereof.
- vii. Each Participant accumulates individual points based on their team's match points. For example, a Participant who won 19-2 in her first match and lost 5-16 in her second match would have a total of 24 individual points (19 + 5).
- viii. Scores for each Participant will be an average of total individual points divided by number of games played. For example, a Participant who collected 159 points over seven games would have an individual score of $22.71 (159 \div 7)$.
- ix. Participant scores across all groups will be displayed at the official Tournament leaderboard at https://padel.volvocarmalaysia.com.
- x. The top sixteen (16) men and sixteen (16) women with the highest scores will go on to the quarterfinals.
- xi. In the event of a tie (same score) for the sixteenth (16th) place, up to four (4) players including players with the tied score and players with the next highest score(s) will compete in three (3) more americano games on Saturday, the 26th of July 2025 at Joy Division Padel. The player with the highest score will move into the quarterfinals.
- xii. Quarterfinals will be held on Sunday, the 27th of July 2025 at Joy Division Padel 2 (JOY2) where the top sixteen (16) men and sixteen (16)

- women will play a final round of americano matches in two separate divisions Men's and Women's.
- xiii. In the event of a tie for individual points in the quarterfinals, the higher-ranked individual in the following sequence ("Americano Tiebreaker"):
 - 1. Most number of matches won; if not, then,
 - 2. Largest difference between total points won and total points lost; if not, then,
 - 3. Lowest total points lost.
- xiv. For the semifinals, teams will be formed from the top eight (8) men and eight (8) women playing in Men's and Women's divisions respectively. The top four (4) Participants in each division will draw lots for a partner from the fifth (5th) to eighth (8th) ranked players in their division.
- xv. Semifinals will be played in a "Fast 7" format where the first team to win four (4) out of seven (7) games is the winner.
- xvi. Finals will be held on the same day and venue in a three (3) set international tournament format without deuces or tiebreakers.
- xvii. If in a game, both teams are tied at game point at 40-40 ("40-all" or "deuce"), the match will end with one (1) decisive winning point from either team ("golden point").
- xviii. The first team to win six (6) games wins the set. If both teams are tied at five (5) game wins each in a set, the set will end with one (1) decisive winning game from either team. The first team to win two (2) out of three (3) sets wins the match.

b. Intermediate Category

- i. Men's Qualifiers will be played with forty-eight (48) teams of two Participants, and Mixed qualifiers will be played with thirty-two (32) teams of two Participants on Saturday, the 26th of July 2025 at Joy Division Padel 2 (JOY2).
- ii. Teams will be randomly grouped into twelve (12) groups of four (4) teams for the Men's category, and eight (8) groups of four (4) teams for the Mixed category.
- iii. Qualifying matches will be played in standard padel scoring, similar to tennis (0, 15, 30, 40...), in a "Fast 5" format where the first team to win three (3) out of five (5) games is the winner.
- iv. Teams in each qualifier group will play against every other team in their group in a round-robin tournament, meaning each team will play at least three (3) matches.
- v. Before each match, teams choose to start the serve or their side of the court by winning a coin toss.
- vi. After each match, winning teams are awarded one (1) match win. Within a group, the winning team from each qualifier group is the one that has the most matches won.
- vii. Participating teams that forfeit their matches automatically award a win to the opposing team.
- viii. Quarterfinals and semifinals consist of elimination rounds with the winning team from each group playing against the winning team from the adjacent group (e.g., Group A vs. Group B, Group C vs. Group D etc.).
- ix. Quarterfinals and semifinals will be held on Sunday, the 27th of July 2025 at Joy Division Padel 2 (JOY2) with elimination matches in a "Fast

- 7" format where the first team to win four (4) out of seven (7) games is the winner.
- x. Finals will be held on the same day and venue in a three (3) set international tournament format without deuces or tiebreakers.
- xi. If in a game, both teams are tied at game point at 40-40 ("40-all" or "deuce"), the match will end with one (1) decisive winning point from either team ("golden point").
- xii. The first team to win six (6) games wins the set. If both teams are tied at five (5) game wins each in a set, the set will end with one (1) decisive winning game from either team. The first team to win two (2) out of three (3) sets wins the match.

c. Advanced Category

- i. Qualifiers will be played with thirty-two (32) teams of two Participants each from two (2) categories Men's and Mixed on Saturday, the 26th of July 2025 at Joy Division Padel 2 (JOY2).
- ii. Teams will be randomly grouped into four (4) groups of four (4) teams each per category.
- iii. Qualifying matches will be played in standard padel scoring, similar to tennis (0, 15, 30, 40...), in a "Fast 5" format where the first team to win three (3) out of five (5) games is the winner.
- iv. Teams in each qualifier group will play against every other team in their group in a round-robin tournament, meaning each team will play at least three (3) matches.
- v. Before each match, teams choose to start the serve or their side of the court by winning a coin toss.
- vi. After each match, winning teams are awarded one (1) match win. Within a group, the winning team from each qualifier group is the one that has the most matches won.
- vii. Participating teams that forfeit their matches automatically award a win to the opposing team.
- viii. The next levels (quarterfinals and semifinals) consist of elimination rounds with the winning team from each group playing against the winning team from the adjacent group (e.g., Group A vs. Group B, Group C vs. Group D etc.).
- ix. Quarterfinals and semifinals will be held on Sunday, the 27th of July 2025 at Joy Division Padel 2 (JOY2) with elimination matches in a "Fast 7" format where the first team to win four (4) out of seven (7) games is the winner.
- x. Finals will be held on the same day and venue in a three (3) set international tournament format without deuces or tiebreakers.
- xi. If in a game, both teams are tied at game point at 40-40 ("40-all" or "deuce"), the match will end with one (1) decisive winning point from either team ("golden point").
- xii. The first team to win six (6) games wins the set. If both teams are tied at five (5) game wins each in a set, the set will end with one (1) decisive winning game from either team. The first team to win two (2) out of three (3) sets wins the match.

- 8. The Organiser, Event Partners and/or Agents shall provide umpires/linesmen and scorekeepers throughout matches, but it is also the responsibility of Participants to keep score and call out faults in fairness and the spirit of good sportsmanship.
- 9. In scoring or gameplay disputes, the umpire's final decision is incontestable. Prolonged escalation of disputes by Participants, hostile or otherwise, will result in forfeiture of the match.
- 10. The Organiser reserves the right to amend gameplay and/or tournament format unconditionally and without prior notice.

PRIZES

- 1. The Organiser is offering cash prizes, merchandise, complimentary court hours from the Event Partners and loans of fully electric Volvo cars worth more than MYR180,000 to the winners of the Tournament.
